- 6. Original Chemical Manufacturers / Principal firm may furnish the name and address of their authorized distributor/ dealers/ stockiest. Where local dealers / stockiest has been nominated by the principal firms, the bills raised by them against our purchase order will be accepted.
- 7. At any time prior to date of submission of tender, Tender Inviting Authority may, for any reason or decision, can modify the terms and conditions of the tender document by a corrigendum displayed on the website of Indian Institute of Technology Dharwad (https://www.iitdh.ac.in). ### 16. RIGHT OF ACCEPTANCE

The Indian Institute of Technology Dharwad reserves the right to accept the whole or any part or portion of the bid; and the bidder shall provide the same at the rates quoted. The Indian Institute of Technology Dharwad reserves the right to reject any or all tenders / quotations or all offers received in response to the tender or cancel or withdraw the tender notice without assigning any reason thereof and also does not bind itself to accept the lowest quotation or any tender and no claim in this regard shall be entertained.

#### 17. DELIVERY

Delivery of goods shall be made by the supplier to DDP, Indian Institute of Technology Dharwad within two weeks of placing of Purchase Order unless specifically mentioned in the Purchase Order. #### 18. INSPECTION

- b) The rate contract of the firm will be subject to verification of the firm's credentials and physical inspection of production units/sales office
- c) The Registrar, Indian Institute of Technology Dharwad shall be the final authority to reject full or any part of the supply which is not confirming to the specification and other terms and conditions.
- d) No payment shall be made for rejected Stores. Rejected items must be removed by the Bidders within one week from the date of rejection at their own risk and cost and replaced immediately. #### 26. FALL CLAUSE

If at any time during the period of contract, the price of tendered items is reduced or brought down by any law or act of the Central or State Govt. or by the tenderer himself, the tenderer shall be morally and statutorily bound to inform IIT Dharwad immediately about such reduction in the contracted prices. IIT Dharwad is empowered to unilaterally effect such reduction as is necessary in rates in case the tenderer fails to notify or fails to agree for such reduction of rates. For purpose of this Clause "Force Majeure" means an event or situation beyond the control of the Supplier that is not foreseeable, is unavoidable, and its origin is not due to negligence or lack of care on the part of the Supplier. Such events may include, but not be limited to, acts of the Purchase in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions, and freight embargoes.

If a Force majeure situation arises, the Supplier shall promptly notify the Purchaser in writing of such conditions and the cause thereof within 21 days of its occurrence. Unless otherwise directed by the Purchaser in writing the Supplier shall continue to perform its obligations under the Contract as far as is reasonably practical and shall be reasonable alternative means for performance not prevented by the Force Majeure event.

If the performance in whole or in part or any obligations under the contract is prevented or delayed by any reason of Force Majeure for a period exceeding 60 days, either party may at its option terminate the contract without financial repercussions on either side.
