Corrigendum

The pre-bid meeting was scheduled on 15th May 2025 at 4 PM at the Administrative Block of IIT Dharwad. As no vendor participated & no query was raised by any bidder in the pre-bid meeting, the terms and conditions of the tender document will remain the same.

Addendum to the tender document

Earnest Money Deposit (EMD) of ₹ 34,000/- (Rupees Thirty-Four Thousand Only) in the form of Demand Draft from any of the Nationalized Commercial Bank drawn in the favour of 'The Registrar, IIT DHARWAD' payable at DHARWAD to be submitted along with Technical Bid failing which, bid will be Rejected.

MSE (Micro and Small Enterprises) who are having valid Udyam registration Certificate and verified startups as recognized by Department for Promotion of Industry and Internal Trade (DPIIT) are Exempted from submitting the EMD, the relevant document to avail exemption is to be submitted in lieu of EMD along with the bid security declaration as per the format given here along with the technical bid. The MSE certificate should be related to transportation or and allied services only. Service Provider/Bidder having annual turnover of INR 500 Crore or more, at least in one of the past three completed financial year(s) are exempted from submitting the EMD, the Bidder should submit the Annual Turnover Certificate issued by the authorized CA firm on its letter head to avail exemption in lieu of EMD along with the bid security declaration.

EMD of unsuccessful Bidders will be returned after 30 days after the Completion of the Technical Evaluation. The EMD of the successful bidder will be returned after the submission of security deposit.

The exemption in turnover and experience will be provided for eligible entities/firms as per GoI norms. The certificate to avail the exemption issued by appropriate government authority/organization/department should be uploaded.
